STANDARD FEES-NEW YORK STATE

Title Premiums: Rates of title insurance premiums are promulgated by the New York State Department of Financial Services. Applicants receive all statutory discounts and rates that they are eligible for.

Reissue Rate Eligibility: Any applicant (as long as they remain in title with no deed transfer) who has purchased or refinanced their home within 10 years of the current transaction receives the statutory reissue rate.

Notary/Title Closer Charge: Starts at \$250 (notaries are independent contractors and set their own rates). Our notaries are always chosen for the expertise as well as their competitive rates.

** Deeds in NYC are subject to an additional charge of \$125 for the RPT Filing for 1-3 Family Residential transactions and \$250 for Commercial transactions.**

** NASSAU COUNTY imposes a Per Block fee of \$150 per block for each recorded document. This additional surcharge has been added to the above fees based on a single block search. In addition, any document recorded against more than one lot will require an additional \$75 fee for each lot after the first.**

** SUFFOLK COUNTY imposes an additional \$30 verification fee for each document recorded. The additional surcharge has been added to the above fees based on a single block search. In addition, any document recorded against more than one lot will require an additional \$60 fee for each lot after the first.**
