Title Premiums: Rates of title insurance premiums are promulgated by the New York State Department of Financial Services and TIRSA Rate Manual. Applicants receive all statutory discounts and rates that they are eligible for.

Reissue Rate: Any applicant who is eligible for a reissue rate pursuant to the terms of the TIRSA Rate Manual will receive a reissue rate.
